Screen Your Teen

Heart screenings are not part of well-child checkups or pre-participation sports physicals, even though SCA is the #1 killer of student athletes and the leading cause of death on school campuses. Screenings include a cardiac risk assessment, EKG (electrocardiogram), echocardiogram, and a consultation with a cardiologist.

WE TAKE PREVENTION TO ♥

Eric’s Foundation provides free heart screenings to youth ages 12 to 25 to identify cardiac abnormalities that put 1 in 300 at risk for Sudden Cardiac Arrest (SCA).



Cardiac Chain of Survival Training

We provide interactive demonstrations of hands-only CPR and how to use an automated external defibrillator (AED)—the only life-saving measures once SCA strikes. When minutes can mean the difference between life and death, it’s critical that bystanders take action.

WE TAKE PREVENTION TO ♥

We are preparing the next generation of life savers by training youth to respond to a cardiac emergency.



Save A Heart, Save A Life AED Program

AEDs are the only way to restart the heart of an SCA victim, but are not mandated in all schools and youth centers. Every minute’s delay decreases the chance of survival by 10%, which is why 92% of SCA victims die. It’s critical for school communities to be as well-practiced in executing the cardiac chain of survival as they are in fire drills.

WE TAKE PREVENTION TO ♥

Eric’s Foundation places AEDs and advocates for the implementation of cardiac emergency response plans anywhere youth congregate.



EP Prescription for Prevention

The landmark Eric Paredes Sudden Cardiac Arrest Prevention Act mandates new student athlete safety protocol in California’s K-12 school-sponsored sports activities. SCA resources are included in the California Department of Education’s 2019 revision of the Health Education Framework. A new SCA prevention training module for pediatric primary care practitioners is now in development.

Legacy Programs

- Fostered sustainability by creating a Screen Your Teen endowment fund
- Partnered with the Boys & Girls Club of San Dieguito to pilot the extension of Eric Paredes Sudden Cardiac Arrest Prevention Act to community youth sports organizations
- Generated new SCA legislation to be announced in 2019
- Provided free resources for California K-12 schools to affect compliance with EP SCA Prevention Act
- Introduced SCA information and resources to the California Department of Education’s 2019 Revised Health Education Framework
- Launched EP Prescription for Prevention—an SCA prevention CME for pediatric primary care practitioners
- Invited to speak on SCA prevention at state conferences, including California School Boards Association, California Organization of School Nurses and California Association for Health, Physical Education, Recreation and Dance
- Produced three educational videos to raise awareness about SCA law, the cardiac chain of survival and heart screenings

Financial Narrative

As we approach the 10th anniversary of Eric’s passing, the foundation focused on creating sustainability to support its ability to continue to offer free screenings, CPR/AED training and AED placement, and it dedicated assets to exploring a new strategic goal to create systemic change in SCA prevention protocol.

- A permanent Screen Your Teen endowment was established.
- Assets acquired through a generous stock donation were restricted to contingency and reserve funds to provide a safety net for operating income fluctuations and the replacement of needed heart screening equipment.
- In 2018, a leadership transition affected a deficit that was offset by this financial planning.
- Beginning 2019, restricted assets will also support seed funding to launch comprehensive programs to advance the long-term standardization of SCA prevention protocol.

The vision of the Eric Paredes Save A Life Foundation is that sudden cardiac arrest will be exposed as a grave and overlooked health risk affecting young people, which will lead to mandatory cardiac screenings and the required placement of AEDs in schools and youth centers.

Mission

Through awareness, education and action, our mission is to influence families, educators, elected officials and the medical community to recognize the incidence of youth sudden cardiac arrest and the importance of preventative care through cardiac risk assessment and heart screenings, and of cardiac emergency preparedness through automated external defibrillators (AED), CPR/AED training and a practiced and coordinated response plan anywhere youth congregate.

Our Purpose

As we approach our 10th anniversary year, our foundation launches a new decade of service to provide critical cardiac safety intervention resources to our community. And looking forward, we embrace a new strategic goal to standardize sudden cardiac arrest prevention protocol at the doctor's office, on the field and in the classroom. The footprint of Eric's legacy will become the foundation of our commitment to create systemic change to protect young hearts in California and beyond.

Eric's Story

Eric was a healthy teen looking forward to being on Steele Canyon High School's varsity wrestling team. An outgoing, energetic, charming young man who loved life, his family and his friends, Eric was known for his smile. He was passionate about making changes so that the world could be a better place. He wanted to be a police officer.

In July 2009, Eric was packing for a much-anticipated family vacation. His mother left the house for an appointment and his father came home for lunch 20 minutes later. He found Eric collapsed on the kitchen floor and started CPR, but it was too late. Eric became a victim of Sudden Cardiac Arrest. Life changed that day, forever.

Eric's parents, Hector and Rhina, established the EP Save A Life Foundation to honor Eric by helping to protect other families from the tragedy of losing a child to a syndrome that could be prevented.
